Introduction What is the APEEE?



- The APEEE EEBI (Association des Parents d'Élèves de l'École européenne) represents all parents of the European School of Brussels I (both sites) at school level and some instances of European school system level
- It is a forum for dialogue and action open to all parents and all language sections together
- We are a separate organisation from the APEEE Services that organises services: bus, canteen (in Uccle), extracurricular activities, swimming and lockers (in Uccle). To have access to the Services, parents must be members of the APEEE (i.e. pay the APEEE membership fee)
- Our representation is based on Class Representatives (4 per class, elected during the Autumn)
- Our Class Representatives also contribute to the larger work of the APEEE: in the APEEE CA, Berkendael Working Group and the school's Educational Councils and undertake other volunteer activities

Most importantly, Class Representatives:



- Coordinate class communication and activities
- Liaise with the APEEE: elect Section Representatives to the APEEE Board (CA), to the school Education Councils (CE) and to the Berkendael Working Group
- Are voting members of the APEEE General Assembly
- Are also automatically voting members of the General Assembly of the APEEE Services
- Help coordinate class participation in the School Party

The APEEE Board



- Our Board has 26 full Board Members with a large body of deputies and other representatives invited to attend
- It is composed by: 16 Section Representatives (1 Primary and 1 Secondary representative from each Uccle section), 1 SWALS representative and 5 Berkendael representatives to be confirmed by the GA + 4 members directly elected by the GA (2 years mandate)
- We meet once a month to implement the decisions taken at the GA and work to bring forward parents' interests at different levels: set up working groups, task forces, approve projects, etc.
- All minutes of the APEEE Board are published on our website

The Education Councils



- One-year mandate (confirmed by CA)
- Uccle: 1 Primary and 1 Secondary representative from each section + 1 Maternelle representative
- Berkendael: 1 representative from each section
- and their deputies
- 4-6 meetings a year

APEEE Activity Report









- COVID-19: Autumn-Winter 2021 have been still under the spectrum of COVID-19. The APEEE advocated for proactive and preventive measures (for example installation and monitoring of COs meters in school) and focused on distance learning to ensure pedagogical continuity for children in quarantine and vulnerable
- Overcrowding and the Future linguistic structure of Brussels Schools
- Further progress in the integration of Berkendael. The APEEE worked to ensure alignment of the pedagogical programmes between the Primary sites of Uccle and Berkendael
- 180 days of schooling, absences of teachers and the organisation of the end of the year for Secondary pupils (cut short of two weeks in June 2022!)



School Access Policy:

- The APEEE worked to ensure a more open access to school for parents, asking for a clear access policy, to be agreed with the stakeholder, not imposed
- The closure of Vert Chasseur entrance and opening of the Opstal gate
- The security and safety agreement between the schools and the APEEEs



Multi-annual and Annual Pedagogical Programme 2021-2022:

- Our CE and CA teams worked to implement the Annual Pedagogical programme adopted in September 2021
- Multi-annual pedagogical programme was not adopted, despite the APEEE requests for years

Main pedagogical issues:

 Distance learning, class trips, project week, European hours, L2 teaching, situation of Locally Recruited Teachers, homework policy, mobile policy, bring your device policy, career orientation and subject choices (MATH 4 and 6), schedules and free spaces in school for free time, teachers' absence and cancelled lessons



Revision of the APEEE Statutes:

- Current Statutes need un update to be in line with the Belgian laws
- The Legal WG worked with the Ernst & Young law firm to update the Statutes to make them in line with the Belgian laws
- The draft new Statutes are under examination by the APEEE CA (first discussion at CA of 15 December 2022)
- Some issues to be resolved: composition of the Board, election procedures, etc.; links to the reflection on the future of Brussels school
- Possible adoption in an extraordinary GA in Spring 2023



- Pedagogical WG: language policy, consultation of stakeholders, New Marking System, BAC results and PISA tests, STEM, distance learning and educational technologies, project weeks and trips
- Well-being WG: emotional intelligence, mobile policy, child protection policy, KiVa and EVRAs programmes, safe internet, mental health
- Community Building WG: Rosa's project, hoodie sales, World Teachers' day, Francis Pirotta Prize

Other projects:

- Autumn call 2021:13 projects proposals, 5 selected for 4250 EUR allocated
- Spring call 2022: 28 project proposals, 5 selected for 4474 EUR allocated

Main successes



- Ensured continuity, despite change of APEEE leadership
- Progress in pedagogy
- Cohesive and strategic CE representation
- Creation of well-being framework
- Progress in the development of credit card payment for the APEEE fees; good relations with the APEEE Services
- Increasing synergies between Uccle and Berkendael; further alignment of pedagogical programmes between Uccle and Berkendael, now the school has added harmonisation across sites as a school priority in the Annual Pedagogical Plan
- Renewed focus on school and system "governance", good cooperation with other APEEs in Brussels, the Commission and INTERPARENTS
- Concluded the first step of the revision of Statutes

Main challenges



- Difficult communication with the school
- Restrictive school access policy
- Weakened community spirit, lack of volunteers and loss of traditions
- Overloaded Secretariat
- Budget in deficit, among others because of high legal fees, inflation and raise of prices because of the war in Ukraine



- Results announced after counting is completed




